

1. Background and objectives

This Cookie Policy explains how our website uses cookies and similar technologies to provide you with an enhanced browsing experience. By continuing to use our website, you agree to the use of cookies as described in this policy.

2. What are cookies?

Cookies are small text files that are placed on your device (computer, smartphone, tablet, etc.) when you visit a website. They are widely used to make websites work more efficiently and to provide information to website owners.

3. How do we use cookies?

Cookies such as Google Analytics help us to collect information on how people use our website, including the number of visitors, and which parts of the site they visit. This information helps us to make improvements to our website and make sure it is meeting your needs.

4. What cookies do we use and why?

4.1 Strictly necessary cookies:

These are essential to enable you to move around the website and use its features.

Alliance Homes	AllianceHomesPrefs	This cookie is used to track acceptance or rejection of Alliance Homes website setting cookies on a user's browser after the user chooses an option in the cookie banner.
Alliance Homes ASP Session Cookie	RequestVerificationToken	This cookie is set by web application built in ASP.NET MVC Technologies. This is an anti-forgery cookie used for

		preventing cross site request forgery attacks.
Alliance Homes ASP Session Cookie	ASP.NET_SessionId	Issued by Microsoft's ASP.NET Application, this cookie stores session data during a user's website visit.
YouTube	Secure-1PSID	This cookie is set by YouTube and is used to authenticate users, store session preferences, and perform security measures.
YouTube	PREF	YouTube cookie to store user preferences.
YouTube	SOCS	Google cookie to track a user's cookie choices.
YouTube	VISITOR_INFO1_LIVE	A cookie set by YouTube to measure bandwidth that determines whether the user sees the new or old player interface.
YouTube	VISITOR_PRIVACY_METADATA	Set by YouTube to store the user's cookie consent state for the current domain.

4.2 Preferences/Functional:

These cookies allow the website to remember choices you make (such as your username, language or the region you are in) and provide enhanced, more personal features. For instance, a website may be able to provide you with local weather reports or traffic news by storing your current region in a cookie. These cookies can also be used to remember changes you have made to text size, fonts and other parts of web pages that you can customise. They may also be used to provide services you have asked for such as watching a video or commenting on a blog. The information these cookies collect may be anonymised and they cannot track your browsing activity on other websites.

Alliance Homes Privacy	AHPrivacy	This cookie is set based on the user's choice on the cookie banner.
Google reCAPTCHA	_GRECAPTCHA	Used by reCAPTCHA on forms.
Google Translate	googtrans	Set by Google Translate if visitor switches to a translation of the website.

4.3. Performance:

These cookies collect information about how visitors use a website, for instance, which pages visitors go to most often, and if they get error messages from web pages. These cookies don't collect information that identifies a visitor. All information these cookies collect is aggregated and therefore anonymous. It is only used to improve how a website works.

Cookie	Name	Purpose
Google Analytics	_ga _gid	These cookies collect information about how visitors use a website, for instance which pages visitors go to most often, and if they get error messages from web pages. These cookies don't collect information that identifies a visitor. All information these cookies collect is aggregated and therefore anonymous. It is only used to improve how a website works.
YouTube	SAPISID	YouTube set this to collect visitor information for videos.
YouTube	SSID	YouTube collect visitor information for videos hosted by YouTube on maps integrated with Google Maps.



Cookie	Name	Purpose
YouTube	YSC	Set by YouTube and is used to track the views of embedded videos on YouTube pages.

4.4 Targeting cookies or advertising cookies:

These cookies are usually placed by advertising networks and are present on the website because of the features incorporated on the website, such as YouTube videos.

Cookie	Name	Purpose
Facebook	_fbp	Facebook sets this cookie to show advertisements to users by tracking user behaviour across the web, on sites that have Facebook pixel or Facebook social plugin.
Google	DV	Google advertising cookie
YouTube	Secure-1PAPISID	Targeting cookie set to profile a website visitor's interests to show personalised Google advertising.
YouTube	AEC	YouTube cookie to protect advertisers from fraud.
YouTube	APISID	YouTube advertising personalisation cookie.
YouTube	HSID	Google Ad optimization cookie to prevent advertising fraud.
YouTube	SID	Google Ad optimization cookie.



Cookie	Name	Purpose
x	guest_id	Set by X (formerly twitter) to track visits from embedded website listing.

5. How to change cookie preferences?

You can control, accept, and decline cookies. If you choose to decline cookies, you may not be able to fully experience the interactive features of our site and any preferences will be lost if you delete cookies. You can change your cookie preferences at any time by clicking the Open Cookie settings in the footer of the website which will bring up a pop-up box allowing the user to define their cookie preferences.
